I. Old Business

a. Approval of Minutes

- ii. UAMS COPH Dr. Su recently vacated the task force. Dr. Greenfield will reach out to some contacts, such as Mark Williams who is the new Dean. Another contact for COPH is Wendy Nembhard.

II. Cervical Cancer In Arkansas – Daniela Ramirez Aguilar, MPH

- a. Daniela Aguilar is the new Cancer Surveillance Manager at the Arkansas Department of Health, Arkansas Central Cancer Registry.
- b. Cervical cancer is the 4th most diagnosed and 4th leading cause of cancer among females
- c. As of 2018, the USPSTF recommends
 - i. screening for females aged 21-29 every 3 years with cytology
 - ii. screening for females aged 30-65 every 3 years with cytology, or every 5 years with HPV test, or co-test cytology and HPV every 5 years.
 - iii. females under the age of 21, over the age of 65, or women who have had a hysterectomy are not recommended for screening.
- d. HPV is the most common cause of cervical cancer
- e. BRFSS data from 2018-2020 shows that: women aged 21-65 who have had a pap test in the past three years slightly decreased in the US and Arkansas at a similar rate. Arkansas was at 80.1% in 2018 and decreased to 76.9% in 2020.
- f. Arkansas has a higher age-adjusted incidence rate than the US and is also less consistent in its trend from 1997-2018. The age-adjusted incidence rate for Arkansas is 10.14 per 100,000, and the five counties with the highest age-adjusted incidence rate are:

 Monroe, Lafayette, Hempstead, Sharp, and Stone.
- g. From 1999-2019, Arkansas is shown to have a higher age-adjusted mortality rate than the US and the trend has more variability than the US. The age-adjusted mortality rate for Arkansas is 3.1 per 100,000, vs the US age-adjusted mortality rate of 2.1 per 100,000
- h. About 90% of cervical cancer cases are due to HPV infections
- i. As of 2017 Gardasil®9 is the only HPV vaccine available in the US
- j. ACIP recommends routine HPV vaccinations at age 11 or 12 for both male and females but can start as early as 9 years of age. Vaccinations can be given through age 26 years if not vaccinated when younger.
- k. The five counties with the lowest vaccination rate of at least 1 dose among children aged 11-14 are: Miller, Hempstead, Marion, Howard, and Fulton.
- I. The five counties with the lowest vaccination rate of at least 2 doses among children aged 11-14 are: Miller, Hempstead, Columbia, St. Francis, and Newton.
- m. According to the American Cancer Society, some research suggests that women who have used an IUD had a lower risk of cervical cancer.
- n. The American Joint Committee on Cancer (AJCC) Cancer Staging Manual has published its 9th edition online and has updated the cervical cancer staging chapter. The AJCC has a course available online to explore the important changes in the new cervix staging and discuss major differences between the 8th and 9th edition. - p. What are the total number of cervical cancer cases in Arkansas? According to https://gis.cdc.gov/Cancer/USCS/ /AtAGlance/ there were 164 cervical cancer cases reported in 2018 in Arkansas and 12,733 cases in the US.
- q. Are there any states with high HPV vaccination rates that are now seeing decreased numbers in cervical cancer? Daniela said that Montana has a lower mortality rate than the US but would need to look into how the HPV vaccine has impacted rates. Rhode Island has an 83% HPV vaccination rate according to data at https://www.americashealthrankings.org/explore/annual/measure/Immunize HPV/state/ALL. Rhode Island students are required to begin the HPV vaccine series before 7th grade entry. Rhode Island incorporates all CDC routinely recommended vaccines into its school immunization regulations. - r. What can we do to expand tele colposcopy in the areas with higher cervical cancer rates? Beatriz said that AMHC has a mobile health unit with a privacy room that can be used to target the areas with higher rates if an OB-GYN can join AMHC on their unit.
