### Discussion on the following issues:

1. Extending renewal deadline and waiving late fees due to public health crisis and financial burden on licensees.

2. Waiving application extension fees for applicants who could not take the national exam because it was cancelled.

3. Possibly issue a provisional license for applicants who cannot take the national exam because it was cancelled.

We cannot do this. There is nothing in our rules/statutes that allows our board to do this.

4. Lack of in-person continuing education opportunities for supervisors to renew license.

See motion # 4 below.

5. Will live webinars or virtual conferences be accepted for 3 in-person continuing education hours required for supervisors?

Motion #4 below allows for more time to get the hours.

6. Approved trainings for Technology Assisted Specialization.

This will be address in the updated FAQ document on the board website.

7. How to document Technology Assisted client contact hours on the 6-month hours report and in our system.

Client contact hours accrued during the public health crisis, that are done through technology assisted methods, will count as face-to-face (direct) client contact hours.

8. Moving rules revisions to public comment period.

Rules revisions will be moved to public comment as soon as possible and a mass email will be sent to all licensees directing them to the website for public comment. If we get the process started any time before April 8<sup>th</sup>, we can get on the legislative calendar by May 15<sup>th</sup>. We want our new rules to go into effect on July 1, 2020.

9. Adding an additional day to the May board meeting.

Discussed conducting interviews online or waiving oral interviews, rules section 6.3(a).

10. Pass/Fail (P will actually count C grades), Credit/No-Credit (CR for Credit will actually count C grades) if students request it at UA. If classes go from grades to pass or credit. UA will tell the student if they have a C grade that it will not count toward licensure and they will have to re-take the class.

This topic was tabled for discussion at the next board meeting.

11. Only 50% of supervision can be done through technology assisted methods. Will the board waive this limit?

This will be address on a case-by-case basis. Possibly having the supervisor and supervisee request a waiver if needed.
