President Lance Lindow called the meeting to order at 1:13 p.m. A flexible agenda was declared.

I. CONSENT AGENDA

MOTION 1: I move the Arkansas State Board of Nursing approve the items on the January 6, 2022, Consent Agenda.

II. COMMITTEE REPORTS

Reports were given by Committee chairs. Motions reflect committee recommendations.

A. FINANCE COMMITTEE

Janice Ivers, the Finance Committee Chairperson, along with Darla Erickson, Administrative Services Manager, covered items for the Finance Committee. The Finance Committee approved their September 9, 2021, minutes and purpose of their committee. The following motions were presented:

MOTION 2: I move that the ADH-Arkansas State Board of Nursing make the following changes on the purpose of the Finance Committee:

• Line 11 - Replace "CAFR" with ACFR".

Darla also confirmed there were no changes in the financial section of the strategic plan. Janice Ivers advised board members that receive a stipend will be receiving a 1099 form.

B. EDUCATION COMMITTEE

Ramonda Housh, Nursing Education Committee Chairperson, along with Tammy Vaughn, ASBN Program Coordinator, covered items for the Education Committee. The following motions were presented:

MOTION 14: I move that the Arkansas State Board of Nursing grant Continued Full Approval to the Arkansas Rural Nursing Education Consortium LPN to RN Associate of Applied Science degree in Nursing Program until the year 2026.

MOTION 15: I move that the Arkansas State Board of Nursing grant Continued Full Approval to the Northwest Technical Institute Practical Nurse Program until the year 2026. Brought by Ramonda Housh and seconded by the Education Committee. **PASSED.**

MOTION 16: I move that the Arkansas State Board of Nursing grant Continued Full Approval to the John Brown University Baccalaureate of Science in Nursing program until the year 2026.

C. PRACTICE COMMITTEE

MOTION 25: I move that the practice committee approve the proposed changes to the Consent Agreement Guidelines, in particular, the addition of paragraph 1.d. which adds that staff may propose a consent agreement: with a Respondent: d. who is guilty of unprofessional conduct."

Brought by Neldia Dycus and seconded by the Practice Committee. **FAILED.**

MOTION 26: I move that the Arkansas State Board of Nursing add the following condition to the appropriate Board motions, Consent Agreements, and Voluntary Surrender forms: If you fail to comply with all terms of your suspension and/or reinstatement during the monitoring period, you may not request to restart the monitoring period until six-months after the date you were determined to be noncompliant.

Brought by Neldia Dycus and seconded by the Practice Committee. **PASSED.**

The Practice Committee approved their minutes from the September 9, 2021, meeting. They also reviewed the purpose of their committee and strategic plan, which is on track.

Susan Brown with PCI Publishing spoke with the Board concerning the 2022 Nursing Expo, which will be held on April 2, 2022, at the Jack Stephens Center, having Donna Terrell as emcee. The nomination deadline for the Nursing Compassion and Outstanding Nurse Education Award is February 28, 2022.
