## Amy Fore and Harold Simpson were not present for the meeting.

The minutes from the October 18-19, 2022, Board Meeting; the December 28, 2022, Emergency Conference Call Meeting; and the January 12, 2023, Emergency Conference Call Meeting were reviewed.

#### **BOARD ACTION:**

Dr. Newsome made the motion that the minutes of the October 18-19, 2022, Board Meeting; the December 28, 2022, Emergency Conference Call Meeting; and the January 12, 2023, Emergency Conference Call Meeting be approved as presented. Dr. Jolly seconded the motion. The vote for the motion was unanimous.

Mrs. Whitmore presented the Board with the financial report for review. Dr. Kirtley asked if it was the will of the Board to continue to waive the original license fees for graduates from the Arkansas Colleges of Pharmacy as well as out of state graduates who plan to work in Arkansas. Dr. Kirtley said the waiver would not include the background check fees since that process has changed and applicants now go to a fingerprint harvester to have their background check initiated.

## **BOARD ACTION:**

Dr. Jolly made the motion to accept the financial report and to approve waiving the fees for graduates as discussed. Dr. Newsome seconded the motion. The vote for the motion was unanimous.

Dr. Kirtley and the Board discussed the Board's \$400,000 appropriation available for the rural loan/scholarship programs at the two Arkansas Colleges of Pharmacy.

## **BOARD ACTION:**

Dr. Jolly made the motion to provide \$300,000 to University of Arkansas for Medical Sciences College of Pharmacy and \$100,000 to Harding University College of Pharmacy for their rural loan/scholarship programs. Dr. Newsome seconded the motion. The vote for the motion was unanimous.

Mrs. Whitmore presented the 2023 Board Member Meeting List and Authority for Expense Reimbursement for Board Members and Stipend Authorization, pursuant to Arkansas Statute 25-16-902 and 25-16-905.

#### **BOARD ACTION:**

Dr. Newsome made the motion to approve the Board Member Meeting List and Authority for Expense Reimbursement for Board Members and Stipend Authorization. Dr. Mitchell seconded the motion. The vote for the motion was unanimous.

Dr. Kirtley said a state representative reached out to him regarding a product for prescription labeling for the visually impaired. He said they would like to pursue this via an outreach program rather than a mandate. Dr. Kirtley said he would notify the Arkansas Pharmacists via the Facebook page.

Dr. Kirtley brought up a current statue regarding parallel restriction with other states. He said staff was recently notified there is a state that does not accept sterile compounding inspections conducted by the Arkansas Board of Pharmacy for Arkansas pharmacies that are seeking to obtain a license to ship to that state. He said they will only allow a NABP VPP Inspection or an inspection by an approved contracted company from their state. Dr. Kirtley said Arkansas will mirror their action and require pharmacies from that state to pass a NABP VPP Inspection to ship sterile compounded medications into Arkansas.
