| ATSC Program Updates | Ruthie Brown with the Arkansas Department Human Services provided the Tobacco Settlement – Medicaid Expansion |
| | Program report (TS-MEP) for July -Sept. The program served 13,621 individuals across all populations for this quarter and this a 720 increase over this same quarter from 2019. TS-MEP was able to leverage14.3 million dollars in federal |

| | ShaRhonda Love (MHI) stated that COVID-19 has impacted their programs again this quarter. They will be hosting |
| | their Health Summit in October again this year. They will be honoring past directors and celebrating the 30-year |
| | anniversary of the Commission during the Summit. The Commission has also worked to secure CARES funds to |
| | assist several organizations to help with PPE, contact tracing, and testing among minority groups. They have worked |
| | with taskforces to assist with mobile health units and partnered with several organizations to conduct media |
| | campaigns. They have served 50 counties, provided over 30,000 COVID-19 tests, conducted more than 50,000 |
| | education encounters, assisted 44 families with funeral expenses, had over 5,000,000 social media impressions, and |
| | also received an extension for their portion of CARES funding. Their mobile health unit has also been helping with |
| | testing, health education, and promoting vaccine usage. They advertised their health careers scholarship and will be |
| | helping 14 students this year. They have also filled their grants coordinator position internally and this person will be |
| | assisting with the mobile health units and ATSC reporting. Their next AMHC meeting will be April 14 th . |
| | Chair Allen thanked Ms. Love and stated that it was a very good report. She also stated that she hoped the next |

| Dr. Becky Hall (UAMS East) stated that they will be announcing a new partnership with COA. She also stated that they will have their MASH camps and it will be virtual but hope to have it in person next year. They are also having Hands on Healthcare classes across the region for high school students, hosting CPR classes for various groups and many other programs. The current count is 450 patients in the clinics and they will also be having a physician in the clinic one-two days per week. This will be advertised along with their three nurse practitioners. They will be partnering with UAMS Cardiology and doing it by telemedicine. It will be a pilot program like their other virtual programs. The Healthy Eating classes continue and as well as the court mandated parenting classes. The Lake Village Center just completed a large flu clinic, and a car seat baby shower. The Fitness Center is slowly getting back to normal but following all safety precautions. Two staff are involved in tobacco cessation training and offering classes in the clinic. They are also working on a food pharmacy in the UAMS East facility, and this a project through the Hunger alliance and Arkansas Food Bank. They have also conducted COVID-19 testing events and will be hosting a vaccine clinic very soon. Their diabetes grant is going well, and they are having good numbers of individual participating. They will also be offering a pharmacist CE class in memory of Dr. Hall's father. It is open to pharmacist around the state and registration is now available. Chair Allen stated that she like the idea of the food pharmacy and that it was innovative. Dr. Hall stated that it will help get people to eat the right foods with their medications. |

| Dr. Amy Leigh Overton-McCoy (COA) said the COAs have been busy trying to expand their programs during the pandemic. Dr. Hall and herself has been looking to secure funding for the new COA at UAMS East in the area due to the disparities in the delta. It will be in UAMS East and be at a lower cost due to sharing space with this facility. This will be focused on dementia care and staff will also be helping with training first responders that interact with dementia patients in the community. COA staff are also working with LTC staff on training regarding falls, medications, physical training, and caregiver support. They have also been working with food insecurity and Arkansas has moved forward in this area. One project has allowed them to work with restaurants and teach residents, but also caregivers. This is done by Zoom. They are also delivering meals in this same program. They will be working with the COPH on health outcomes and evaluation services. Caregiving is also a priority and they want people to stay in their homes. They have a pilot program that is training caregivers with one-on-one coaching. Technology has also expanded, and older adults are using it more to engage in virtual classes but also provide basic instruction in work-related skills. The COA is also looking for ways to expand through the pandemic and it has brought challenges but also provided opportunities. Chair Allen praised the COA and asked about the training for caregivers and was it available to anyone? Amy stated that it was and that their centers offered it. They are seeking to add funds to allow people to access Wi-Fi. They also have a lending library where they can assist as well. Each center has different capabilities and specialties. Chair Allen asked if anyone had questions for the COA? |

| Dr. Mark Williams (COPH) stated they have been busy with many projects. They continue to publish the COVID-19 pandemic report for the state with data from ADH and try to provide projections for all to review as to what might be happening. State government looks at it closely, as well as health care leadership around the state. COPH leadership is also looking at the finalist for the McMath Obesity Chair and the Center for the Obesity Studies. They have many qualified individuals. They have six new grants and contracts, and two are focused on nicotine in youth. Several others are looking at data sharing, testing of viruses, and also testing and spread with COVID-19 in prisons. Lastly, Dr. Joe Bates has worked on a film regarding COPH and its history related to politics and public health. They plan to share it with the Commission to view. Also, the COPH is hosting seminars and webinars related to general health awareness. Dr. Williams stated he would take any questions. Chair Allen stated she would like to view the film regarding the COPH. Dr. Williams said he would share, and Matt stated that he would share as soon as he received it. |

| Joy Gray (TPCP) provided a brief summary since last meeting. The program has compiled a panel card showing the effects of COVID-19 with tobacco usage and provided it at testing and vaccine clinics. Many programs are doing virtual programs in the schools. Zoom and other programs are being purchased to do this. BeWell Baby is starting soon, and it will be by phone due to COVID-19. They can still call in, get counseling, use a nicotine test, and then they then can receive a voucher for diapers, wipes, etc. if they are tobacco free for a specific time frame. All partners and ADH Local Health Units will be assisting. It may have a small start, but it will grow. Other surrounding state use it now. They are also staring to get into substance abuse and mental health centers around the state. They will show them how to incorporate cessation into their current programs. BeWell is still enrolling at normal rates. All call centers are down and TPCP's rates are down slightly as well, but the CDC's TIPs campaign will start soon. It usually enrolls more individuals into cessation efforts as it starts up on March 1 st . TPCP's main priority has been to stress the risk of COVID-19 with smoking. Chair Allen asked if there was data that showed smoking and tobacco rates had increased with the stress of the pandemic? She said that alcohol usage was up. Joy stated that there were some that had called but decided that they did not want to quit due to the stress and quitting was a not an option at this time. Dr. Bala stated that the numbers will be out later this year, but some data did show alcohol use was up. |
| Leslie Humphries (ABI) stated that there were 15 COVID research reports currently ongoing. ASU is working on rapid testing using chest x-rays with artificial intelligence. There is also a project with bats, and other animals, and how viruses transfer to humans. ACH is researching if COVID-19 can transmit though breastmilk. One other project is focused on improving rapid tests. UA Division of Agriculture is looking at spread in restaurants among customers, tables, menus, and other items that individuals often touch. |
