Dear Mr. Hudson,

Under the authority vested in the Secretary of the Arkansas Department of Health by Act 114 of 2023, the State Board of Athletic Training will be reducing certain fees.

The fees to be reduced and the new amount charged will be as follows:

- Licensure by Examination/Certification Application Fee: Current = \$15.00 / New = \$1.00
- Licensure by Examination/Certification Initial Licensure Fee: Current = \$100.00 / New = \$5.00
- Licensure by Examination/Certification/Reciprocity for full-time graduate students certified by Board of Certification for The Athletic Trainers Certified Application Fee: Current = \$25.00 / New = \$1.00
- Licensure by Examination/Certification/Reciprocity for full-time graduate students certified by Board of Certification for The Athletic Trainers Certified Licensure Fee: Current = \$50.00 / New = \$3.00
- Licensure by Reciprocity Application Fee: Current = \$25.00 / New = \$1.00
- Licensure by Reciprocity Licensure Fee = \$100.00 / New = \$15.00
- Temporary Permit Application Fee: Current = \$25.00 / New = \$1.00
- Temporary Permit Licensure Fee: Current = \$300.00 / New = \$15.00 quarterly
- Licensure Renewal Fee: Current = \$50.00 / New = \$3.00
- Licensure Renewal Fee for graduate students certified by Board of Certification for The Athletic Trainer: Current = \$25.00 / New = \$1.00

This fee reduction will be in effect beginning July 1, 2025, and end June 30, 2026. These regulatory fees and charges have been reduced in light of the fund balance accumulated by the board and the reduction may or may not apply in future years.
