The purpose of this memorandum is to provide corrections to typographical errors after the publishing of the 2014 Inpatient and Emergency Department Data Submittal Guides. The corrections will be incorporated in the next scheduled revision of the Data Submittal Guides.

## 2014 Inpatient Data Submittal Guide Corrections

- Page 13, 6.2 1450 & 1450 Record Type 10 Provider Data, Field 10 The current picture "X(25)" is a typographical error and should read "X(14)".
- Page 21 22, 6.9.3 Sequence 3 1450 Medical Data (Procedures), Fields 25 through 46 The position locations for fields 25 through 46 are incorrect. The following table has the correct position locations.

- Page 24, 6.10 1450 & 1450Y2K-Record Type 80-8N- Physician Data, Field 12 The "From" location position "84" is a typographical error and should read "85".
- <u>Page 42, Principal Procedure Code, General Comments</u> The general comments are incorrect and should read as follows: "The coding method used must be ICD -10-PCS for inpatient submissions. Enter the code left justified without the decimal."
- <u>Page 42, Procedure Coding Method Used, General Comments</u> The definition for the "0" code is incorrect. It should read "ICD-10-PCS".

## 2014 Emergency Department Data Submittal Guide

- Page 20, 1450 & 1450Y2K-Record Type 80-8N Physician Data, Field 5 & 6 The "Thru" location position for Field 5 of "35" is a typographical error and should read "36". The "From" location position for Field 6 of "36" is a typographical error and should read "37".
- Page 38, Principal Procedure Code, General Comments The general comments are incorrect and should read as follows: "The coding method used should be ICD -10-PCS. If some other coding method is used, the "Procedure Coding Method Used" must indicate the code for all digits and decimal. Enter the code left justified without the decimal."
- <u>Page 38, Procedure Coding Method Used, General Comments</u> The definition for the "0" code is incorrect. It should read "ICD-10-PCS".
