## A. EDUCATION COMMITTEE

Tabitha Lancaster, Education Committee Chairperson, along with Tammy Vaughn, ASBN Program Coordinator, covered items for the Education Committee. The following motions were presented:

#### **B. PRACTICE COMMITTEE**
