


Financial Report	Dr. Reed introduced Attorney Jessica Kloss as our newly designated board counsel from the Arkansas Attorney General's office.  The February 20, 2025, meeting minutes were distributed prior to the meeting. With no request for changes to the minutes, a motion was made by Dr. Jones and seconded by Dr. Hertzog to accept the minutes as presented. The motion passed.  Executive Director, Suzette Weast presented the financial report. Cash reserves are lessening from the fee reduction as expected. The Legislative Committee voted for the licensing fee reduction to continue another year to ensure licensing boards have only three years of operating costs in reserves. The reduction only applies to licensing fees and not to fines or administrative fees. Fees are expected to return to the regular rates on July 1, 2026. The board did not accept the request which conflict with the Arkansas State Board of Optometry rules and regulations so Dr. Ingram will remain retired. Dr. Bowman has been inactive for 3 years and requested to transition back to active with proof of continuing education. He decided to remain inactive since the rules require applying as an endorsement candidate after the lapse of licensure.</p>	<p>Mrs. Weast</p>

Both motions passed.</p> <p>There are no complaints to report.</p> <p>NBEO has two new exam sections: injection skills (ISE) and laser/surgical procedures (LSPE).</p> <p>The topic was introduced for new applicants and endorsement candidates to be required to take the advanced procedures certification.
