The Annual Report of the Arkansas State Board of Nursing is prepared and distributed in accordance with the *Nurse Practice Act* of the State of Arkansas, Arkansas Code Annotated § 17-87-203 (4). It contains information regarding the Board's activities, as well as information about nurses licensed by the Arkansas State Board of Nursing, organized by licensure type and county of residence. Data on the supply and distribution of nurses licensed is included in Appendix A of this report. This data is obtained from responses during license renewal.

From the Director



It is with great pleasure that I present to you the Arkansas State Board of Nursing's 2024 Annual Report. This report reflects the Board of Nursing's activity from July 1, 2023, through June 30, 2024.

The mission of the Board of Nursing is to protect the public and act as their advocate by effectively regulating the practice of nursing. The Arkansas State Board of Nursing is composed of 13 board members. In accordance with state statutes, there are seven registered nurses (RNs) on the Board. Of these seven RNs, two are advanced practice registered nurses with at least one of them holding prescriptive authority; one has (as their highest educational preparation) a diploma, two have an associate degree and two have a baccalaureate or higher degree in nursing. There are three licensed practical or licensed psychiatric technician nurses and two consumers, one of which

represents the elderly population. One additional at-large member is a licensed registered nurse or licensed practical nurse. One registered nurse must be an educator.

The agency consists of an administrative staff of 30 hard-working and dedicated individuals.

The Board is involved in nursing regulation on the local, state and national levels in order to address the ever-changing needs of the citizens of Arkansas. The annual report reflects the myriads of activities conducted by the Board and its staff in their commitment to fulfilling the mission of public protection. As you review this information, I hope you find the report informative and useful.

Legislative Mandate

The Arkansas State Board of Nursing has a legislative mandate to protect the public by assuring that any person practicing nursing is qualified to do so. The law governing the Board of Nursing is covered under the *Nurse Practice Act* (NPA) of the State of Arkansas (reprinted from Arkansas Code Annotated § 17-87-101 – § 17-87-711). In keeping with the power and responsibilities in the NPA, the Board:

- Maintains an office for the administration of its business and employs personnel necessary for carrying out its functions; examines, licenses, and renews licenses or certificates of duly qualified applicants for nursing licensure and medication assistant certification.
- Prescribes minimum standards, approves curricula, surveys, and approves educational programs preparing nurses for nursing licensure and medication assistant certification.
- Promulgates rules necessary for the implementation of the NPA and submits these to the Arkansas legislative bodies for review.
- Develops and recommends role levels of technical classes of nursing service and practice to state and federal health agencies and to public and private administrative bodies.
- Conducts disciplinary proceedings and causes prosecution of persons violating the NPA; and
- Grants certificates of prescriptive authority to qualified advanced practice registered nurses.

Committees

Administrative

The Administrative Committee serves in an advisory capacity and makes recommendations to the full Board which align with the Board's mission of public protection. The committee provides oversight on administrative matters and is responsible for providing direction of the agency. Some of the activities conducted by the committee include developing and revising agency policies, addressing legislative issues, evaluating the strategic plan, and providing guidance to staff on various administrative functions. The committee chairperson is Veronica Harmon, RN.

Education

The Nursing Education Committee reviews nursing education issues and standards for the purpose of making recommendations to the Board. The committee proposes guidelines for use in implementing the *Rules* regarding nursing education programs, reviews new and established nursing education programs and addresses current nursing education issues and trends. During FY2024, the Education Committee reviewed ten Continued Full Approvals, three Prerequisite Approvals, three Initial Approvals, and three Full Approvals for nursing programs. The Committee also reviewed new satellite locations for approved medication assistant-certified programs. The committee chairperson is Tabitha Lancaster, RN.

Finance

The ASBN Finance Committee is a group of designated board members who provide recommendations to the full board. Board members are responsible for the oversight of ASBN, so the Finance Committee is charged with the review of ASBN's financial information. Phillip Petty, RN, is committee chairperson. The financial information reviewed by the Finance Committee includes, but is not limited to, the following:

Committees

Practice

The ASBN Practice Committee reviews and researches best practices for current issues in nursing practice and recommends official positions or other actions to the full Board. The committee monitors open investigations for trends in length of time cases are open and makes recommendations to the Board. The Practice Committee addresses other issues as assigned by the Board President. Cassie Gonzales, APRN, is the committee chair.

Prescriptive Authority

The Prescriptive Authority Committee functions in an advisory capacity to assist the Board with oversight and implementation of the provisions regarding prescriptive authority. The committee is composed of six members appointed by the Board and approved by the governor. Four members are APRNs with at least three members holding certificates of prescriptive authority and active DEA numbers. One member is a licensed physician who has been involved in a collaborative practice agreement with an APRN for at least five years. One member is a licensed pharmacist who has been licensed at least five years.

Full Independent Practice

In 2021 the legislature passed Act 412 which provides a pathway for certified nurse practitioners to apply for full independent practice removing the requirement of a collaborative practice agreement for prescriptive authority. Act 412 also created the Full Independent Practice Credentialing Committee (FIPCC), a separate committee comprised of four physicians and four advanced practiced registered nurses appointed by the governor to review and approve all applications for full independent practice. This committee is independent of ASBN and works in collaboration with the Arkansas State Medical Board (ASMB). ASBN Director and ASMB Director serve as ex-officio nonvoting members on the committee. Amendments were made in 2023 that added eligibility for clinical nurse specialists. Minimum eligibility requirements for applicants include 6,240 hours of practice under a board approved agreement.

ASBN began accepting applications August 1, 2022, through the Arkansas Nurse Portal. The FIPCC meets quarterly to review applications.

The ADH-Arkansas State Board of Nursing does not receive appropriations of general revenue from the state. Nurse licensure fees constitute the agency's primary financial support. The FY 2024 total revenue was \$4,200,891.14. Expenses for the fiscal year totaled \$3,786,375.60. Total revenue and expenses include Board of Nursing operating fund, nursing student loan fund, continuing education workshop fund and grant fund.

The Board is required to pay 1.5 percent of revenue fees to the Treasury of the State of Arkansas. These funds are credited to the State's General Fund for appropriation to various other agencies and services of state government. The Board paid \$60,793.78 to the General Fund for FY 2024. The financial statements and graphs on the following pages reflect the breakdown of revenue and expenses for the fiscal year 2024.

The Nursing Student Loan fund titled the Faith A. Fields Nursing Scholarship Loan is a separate fund used only for the purpose of providing loan/scholarships to nursing students and nurse educator students. The program is funded by donations that are deposited into the designated fund. Up to \$100,000.00 may be transferred from the Operating Fund each year to fund the program. From these funds, nursing students are awarded loans that can become scholarships if they work in the state of Arkansas after graduation and licensure. In addition to the current recipient selections, beginning in the Fall of 2017, each year two recipients are selected to receive the Faith A. Fields Scholarship Loan in honor of the memory of Jill Hasley, the ASBN Program Coordinator in the Advanced Practice Department from June 25, 2011, until her death on July 30, 2016.

The Continuing Education fund is also a separate fund that allows the Board of Nursing to collect registration fees for the educational workshops provided by the Board of Nursing. The designated funds from the registration fees are used to offset the costs associated with providing this service.

The Grant fund is a special revenue fund established in FY2018 to comply with Act 521 of 2017. Up to \$173,000.00 may be transferred from the Operating Fund each year to fund the program. This allows ASBN to provide a grant to the Arkansas Center for Nursing, Inc.

Faith A. Fields Nursing Scholarship/Loan

The ASBN nursing student loan program was established in 2003 and legislatively revised by Act 9 in 2009. The purpose of the program is to provide funding for individuals attending a nursing program that will lead to licensure as a nurse or provide a higher degree in nursing. The goal is to increase the number of nurses in practice settings and faculty in nursing education programs. Representative Tracy Pennartz, the sponsor of the 2009 legislation supported nursing education and requested emphasis be placed on nurses desiring to teach in an Arkansas nursing education program.

Applicants apply for one of two types of scholarship/loan. Applicants entering a nursing program that leads to initial licensure as a nurse or who desire to remain in the practice setting apply for the Practice Loan. Applicants who are already a nurse and currently teach or plan to teach in a nursing program apply for the Educator Loan. Recipients of either loan type may have their loans converted to scholarships according to the terms of the loan. Recipients of the Practice Loan must practice full-time as a nurse in an Arkansas facility one year for each year of the loan and the Educator Loan recipients must teach full-time in an Arkansas nursing program one year for each year of the loan.

Loans are made to students around the state with most loans made to students living in central Arkansas. The diagram below displays the counties in which recipients from FY2024 reside.

Educational Programs

Nursing education programs attended by the twenty (20) individual recipients of fiscal year 2024 were from a variety of educational levels. The table indicates the breakdown of nursing educational programs attended by recipients.



Loan Recipient Status

Each recipient has a nine-month grace period following graduation to allow time to secure a nursing position that meets the contract requirements. During this time and while completing their work requirements they are placed in monitoring status.

Since 2010, two hundred one (201) individuals have received a scholarship/loan from the Faith A. Fields Scholarship/Jill Hasley Scholarship. At the end of fiscal year 2024, one hundred thirty-four (134) have completed

the terms of their scholarship by practicing/teaching in Arkansas or repaying their scholarship funding. Eight (8) recipients will continue receiving scholarship money for the upcoming fiscal year. Thirty-one (31) recipients are being monitored for compliance with the terms of the loan and twenty-eight (28) are in collections for repayment of the loan due to failure to fulfill the terms of the contract. Loan recipients who fail to complete the nursing program or graduate and do not comply with the terms of the loan (fail to practice or teach in an Arkansas institution) are placed into repayment status.

Number and Types of Loans

In 2021, the amount appropriated for each fiscal year was increased from \$50,000 to \$100,000. The table below demonstrates the amount disbursed for scholarship awards during the last five years by fiscal year. A total of thirty-six (36) loans were granted during the reporting period totaling \$77,750. For the fall 2023 semester, one (1) educator loan and nineteen (19) practice loans were disbursed. The loans awarded for the following spring semester (2024) consisted of a continued funding of one (1) educator loan and fifteen (15) practice loans. The table to the right depicts the amount of funding allocated for the two loan types during the fiscal year.







Discipline

The Arkansas *Nurse Practice Act (NPA)* and its *Rules* provide that the Board may deny, suspend, revoke, limit or otherwise discipline any license or privilege to practice nursing or certificate of prescriptive authority issued by the Board or applied for in accordance with the provisions to discipline a licensee upon proof that the person:

- (1) Is guilty of fraud or deceit in procuring or attempting to procure a license to practice nursing or is engaged in the practice of nursing without a valid license;
- (2) Is guilty of a crime or gross immorality;
- (3) Is unfit or incompetent by reason of negligence, habits, or other causes;
- (4) Is habitually intemperate or is addicted to the use of habit-forming drugs;
- (5) Is mentally incompetent;
- (6) Is guilty of unprofessional conduct;
- (7) Has had a license, privilege to practice, certificate, or registration revoked, suspended, or placed on probation or under disciplinary order in any jurisdiction;
- (8) Has voluntarily surrendered a license, privilege to practice, certification, or registration and has not been reinstated in any jurisdiction; or
- (9) Has willfully or repeatedly violated any of the provisions of any chapter of the Arkansas NPA.

An individual is not eligible to receive or hold a license if that individual has pleaded guilty or nolo contendere to or been found guilty of any offense listed in § 17-3-102(a) unless the persons requests and the Board grants a waiver pursuant to in § 17-3-102(b). Investigations of inquiries and reports are completed by Board staff, legal counsel, contract investigators or other governmental agencies. During its investigations, the staff has continued to emphasize the Board's commitment to the due process afforded each licensee under the provisions of the *NPA* and the Administrative Procedures Act, as well as the Board's charge to protect the public. During the reporting period, 1,710 complaints were received, 1,278 cases were assigned to an investigator and 1,277 cases were closed.

Disciplinary Hearing is held – If the Board finds that the conduct which was charged did not occur or that the conduct which did occur is not a violation of the <i>Nurse Practice Act</i> , the case is dismissed, and no further action is taken. <i>OR</i> If the Board finds the nurse violated the <i>Nurse Practice Act</i> : Disciplinary Order – The Board issues an Order setting forth the discipline. This Order becomes effective the day it is signed. Appeal – The licensee may appeal this decision to the circuit court of the county in which he/she resides or the Circuit Court of Pulaski County, AR.

Alternative to Discipline

Arkansas Alternative Program (ArNAP) is a non-public, abstinence-based, non-disciplinary monitoring program that was legislatively created in 2017 to help licensed nurses and applicants who have a drug or alcohol abuse problem, or addiction.

The mission of ArNAP is to protect the public by providing education, consultation, referral, monitoring, and support for participants licensed or certified by the Board of Nursing with conduct related to substance abuse and use. The program is administered by the Arkansas State Board of Nursing and is available to individuals who meet the program criteria.

To participate in ArNAP, a nurse must meet the following criteria:

- Hold an Arkansas nursing license, certificate or be eligible for licensure or certification.
- Otherwise, be eligible for continued licensure or certification under the Arkansas *Nurse Practice Act*.
- Acknowledge a drug or alcohol abuse problem or addiction; and
- Voluntarily request participation in ArNAP.

An individual will be denied participation in ArNAP if they do not meet the eligibility requirements, or if any of the following is applicable:

- Diverted controlled substances for reasons other than self-administration.
- Engaged in behaviors resulting in patient harm.
- Have prior discipline by any board of nursing for substance abuse or diversion; or
- Demonstrated unsuccessful participation resulting in termination from ArNAP or another similar program offered in another jurisdiction.

Process for Entering ArNAP

- 1. A complaint or referral is sent to the Board.
- 2. The complaint or referral is reviewed to determine if the individual is eligible for ArNAP.
- 3. If the individual is eligible for ArNAP and requests to participate in ArNAP, the individual is required to sign an Agreement.
- 4. The Agreement addresses several initial items, such as acknowledging the drug or alcohol abuse problem or addiction, placing current nursing licensure on inactive status, obtaining an evaluation from a Board-approved evaluator for an addiction evaluation, and agreeing to comply with all treatment recommendations.
- 5. Once an ArNAP staff member has reviewed the individual's evaluation report, a detailed contract is presented to the individual. The ArNAP Contract contains the terms and conditions that the individual must comply with while enrolled in ArNAP, which may include, but is not limited to the following: daily check-in with a drug screening monitoring company for random drug screens; therapy/counseling; support group meetings (such as 12-step); abstinence from drugs, alcohol, and abuse potential medications; employment restrictions; and submission of required reports (i.e. self, aftercare, treatment provider, and employment).
- 6. The term of ArNAP varies from one (1) to five (5) years depending upon the complaint or referral, and the diagnosis. A disciplinary flag will not be placed on the individual's license if the individual successfully completes ArNAP.

Alternative to Discipline

ArNAP Statistics for July 1, 2023, through June 30, 2024

One hundred twenty (120) individuals were screened for eligibility for ArNAP during the reporting period and forty-three (43) individuals entered ArNAP in lieu of disciplinary action. One individual was ordered into ArNAP through a Board hearing. At the end of the reporting period, eighty-six (86) nurses were currently being monitored in the ArNAP program.

Thirty-seven (37) individuals have completed ArNAP successfully during this reporting period, meeting all their monitoring requirements. The program success rate at the end of fiscal year 2024 is 76 percent.

Individuals who fail to meet their monitoring requirements are discharged from ArNAP and referred to the Board for disciplinary action. During the reporting period, fourteen (14) individuals were discharged for failing to meet the requirements of ArNAP. Nine (9) of the individuals chose to voluntary surrender their license, three (3) nurses chose to enter Consent Agreements (probation), and two (2) individuals were referred to hearing.



The graph below identifies the highest level of licensure of individuals who entered ArNAP during the reporting period.

The Nurse Practice Act requires that any person practicing as a(n)

- Registered Nurse
- Advanced Practice Registered Nurse
- Registered Nurse Practitioner
- Practical Nurse, or
- Psychiatric Technician Nurse

in this state shall be licensed by the Arkansas State Board of Nursing. Legislation enacted in 1979 authorized the licensing of registered nurse practitioners. Act 409 of 1995 created advanced practice registered nurse licensure. This licensure includes the previous categories of certified registered nurse anesthetist and certified nurse midwives and adds licensure of certified nurse practitioners (previously known as advanced nurse practitioners) and clinical nurse specialists. Appendix A gives totals of nurses licensed in Arkansas by licensure category and county of residence. The information is derived from questions that are completed on the licensure renewal forms. Incomplete data indicates that the licensee did not provide that information.

Advanced Practice Prescriptive Authority

Licensure by Examination

Licensure examinations for registered nurse and practical nurse candidates are administered via computerized adaptive testing. State boards of nursing contract with the National Council of State Boards of Nursing (NCSBN) for these examinations. In Arkansas, tests are administered by technology centers located in Little Rock, Fort Smith, Rogers and Texarkana. A candidate may test at any center nationwide or internationally for licensure by the Board that provided the authorization to test.

The licensure examinations have one purpose: to test knowledge, skills and abilities essential to the safe and effective practice of nursing at the entry level. The use of national RN and PN examinations facilitates licensure by endorsement from one jurisdiction to another. The passing standard is set by a panel of practicing nurses who are knowledgeable of entry-level nursing practice. Membership on the panel is open to all NCSBN jurisdictions. Examination results are reported to boards of nursing and to the candidates as either "pass "or "fail". Unsuccessful candidates are provided with a performance report that gives information on areas for remedial study.

The Board participates in the test development system administered by the testing service of the NCSBN. The Arkansas Board approves practicing nurses to participate in RN and PN item writing, item review and standard-setting panel.

Temporary permits may be issued to Arkansas graduates of a nursing program. This permit allows a nurse to practice between graduation and receipt of results of the first examination for which the licensee is eligible.

Licensure by Endorsement

Pursuant to the Arkansas *Nurse Practice Act (NPA)*, the Board may issue a license to practice nursing by endorsement to an applicant who is duly licensed as a nurse under the laws of another state, territory, or foreign country if the applicant meets Board qualifications. Applicants for endorsement must have successfully completed a nursing education program, the appropriate licensure examination and must be verified by the jurisdiction of original licensure. An amendment to the *NPA* enacted by the 1980 Special Session of Legislature, provided for issuing temporary permits to qualified endorsement applicants holding current licensure in other states.

License Renewal

The Nurse Practice Act requires biennial license renewal for practicing nurses. Renewal reminders are mailed at least sixty days before the license expiration date. Nurses who allow their licenses to lapse and who have not practiced nursing during the preceding licensure period may be reinstated upon request, payment of the renewal fee and late penalty, and after meeting the continuing education requirements. Nurses who do not renew are in good standing as long as they do not practice nursing in Arkansas. Legislation to require continuing education prior to license renewal was passed in the 2001 Legislative session. Approved renewals based on application submission are reflected in the table.

Retired Licenses

Any licensee who desires to retire from the practice of nursing for any length of time in this state and submits an electronic application will have their current license placed on Inactive Retired status. While retired, the licensee shall not practice nursing. However, the nurse may use respective credentials. When the licensee desires to resume practice, he or she shall submit a renewal application, which shall be completed and submitted with a reinstatement fee and the current renewal fee. The number of current retired licenses issued during the reporting period is 144.

Military Automatic Licenses

The Arkansas State Board of Nursing (ASBN) is committed to honoring the service of active and reserve uniformed service members, uniformed service veterans and their families.

As mandated by Act 137 of the 2023 Arkansas legislative session, the ASBN has adopted rules to assist active and reserve uniformed service members, uniformed service veterans, and their spouses in obtaining initial nursing licensure. ASBN provides an opportunity for automatic temporary permit licensure and preferential processing during the issuance of a permanent license. The total number of automatic licenses issued to active-duty military members, veterans, and their spouses for Fiscal Year 2024 is listed below.

Criminal Background Checks

Federal and Arkansas criminal background checks are required of all individuals applying for an initial license in Arkansas. During the 2023-2024 fiscal year, 5,527 Arkansas and federal criminal background checks were conducted. There were 418 investigations initiated, and 462 investigations resolved on applicants with a positive criminal background check.

Education

The Arkansas State Board of Nursing staff conducts presentations, continuing education workshops, and online courses on a regular basis throughout the state as included in the Continuing Education Presentations table below. Additionally, continuing education courses were developed and are offered on a continuous basis thus expanding our online presence. Online course offerings have the advantage of reaching a larger audience. Education Programs

The Arkansas State Board of Nursing has statutory authority to oversee nursing educational program compliance with mandated regulations and educational standards as established by the Arkansas legislature. A nursing program that is approved initially progresses through a three-tiered process of approval that includes Prerequisite Approval, Initial Approval and Full Approval.

A nursing program that is approved continues to be reviewed for continued compliance with the

educational standards as delineated in the *Rules*. The staff periodically conducts a program review to verify compliance. A new program has an onsite survey three years after initial full approval. Established programs have an onsite survey every five years, or if they have continued accreditation status from a

Education Program Enrollment

Enrollment in nursing education programs is reported to the Board by program directors annually in January. The enrollment data submitted and reported is for the previous 2023 academic year. Enrollment figures are inclusive of only students enrolled in nursing courses that lead to a certificate or degree in nursing.

Compared to the previous ASBN Annual Report, enrollment has decreased in Arkansas nursing programs during 2023. The practical nursing programs enrollment decreased from 1,235 students enrolled during 2022, to 1,128 students enrolled during 2023. This is a decreased enrollment of 107 students, or 8.6 percent. The associate degree nursing programs have decreased enrollment from 2,433 students enrolled during 2022, to 2,338 students enrolled during 2023. This is a decreased enrollment of 95 students, or 3.9 percent. The Bachelor of Science in Nursing programs have decreased from 2,584 students enrolled during 2022, to 2,064 students enrolled during 2023. This is a decreased enrollment of 520 students, or 20.1 percent. The Master's Entry into Professional Nursing program has also decreased enrollment from 31 students in 2022, to 21 students in 2023. This is a decreased enrollment of 10 students, or 32.2 percent.

Overall, Arkansas nursing programs have decreased enrollment of students from 6,283 students in 2022, to 5,551 students in 2023. This is an overall decrease of 732 students enrolled, or 11.6 percent.

Licensing Examination Data

The licensure examinations for registered and practical nurses are administered via computer adaptive testing (CAT). The performance, by program, for first-time candidates taking the National Council Licensure Examination for Registered Nurses (NCLEX-RN^{*}), regardless of where the examination was taken during the FY24 reporting period (July 1, 2023, to June 30, 2024) is shown in the table below. FY24 NCLEX Performance by Program charts below are inclusive of outcomes from the NCSBN Next Generation NCLEX (NGN) examination, that was launched on April 1, 2023. The NGN is an enhancement to the current licensure exam and is based on the *NCSBN Clinical Judgement Measurement Model (NCJMM)*. The *NCJMM* is a framework for valid measurement of clinical judgment and decision making within the context of a standardized, high-stakes examination (ncsbn.org).

Compared to FY23, the overall NCLEX-RN volume for Arkansas increased from 2,163 first-time testers to 2,195 first-time testers. This is an overall 1.4 percentage point increase in FY24. The pass rate performance for the RN programs in Arkansas also increased significantly from 85.3 percent in FY23 to 92.3 percent in FY24. This is a 7-percentage point increase in FY24.

The performance, by program, for graduates of Arkansas programs taking the National Council Licensure Examination for Practical Nurses (NCLEX-PN[®]) for the first time, regardless of where the examination was taken during the FY24 reporting period (July 1, 2023, to June 30, 2024) is shown in the table below.

Compared to FY23, the overall NCLEX-PN volume for Arkansas increased from 776 first-time testers to 795 first time testers. This is an increase of 19 students, or an overall of 2.4 percentage point increase for FY24. The pass rate performance for the PN programs in Arkansas increased significantly from 86.0 percent in FY23 to 94.2 percent in FY24. This is an 8.2 percentage point increase for FY24.

- Overall, 186,965 first-time U.S. graduates took the NCLEX-RN examination during FY24, as compared to 198,287 who tested in FY23. This represents a decrease of approximately 5.7 percent.
- The overall passing rate for the first-time U.S. graduates taking the NCLEX-RN during FY24 was 92.1 percent, as compared to 83.2 percent in FY23. This represents an increase of 8.9 percentage points.
- A significant increase in first-time foreign educated graduates taking the NCLEX-RN was also identified. There were 66,780 first-time testers in FY24, as compared to 59,338 in FY23. This represents an increase of approximately 12.5 percent.

Medication Assistant – Certified

Act 1423 of 2005 gave the Board authority to grant certification to qualified unlicensed persons to administer certain medications in designated facilities determined by the Board. The Board allows medication assistants only in Arkansas nursing homes or a facility operated as a local correctional facility as defined by ACA § 12-41-107, which nursing supervision is available and nurse patient ratios are legislatively required. This authorization included persons wo have met certain qualifications in Arkansas or who have met substantially similar qualifications and held similar credentials under the law in another state. In addition, in 2007, people who have completed a certain portion of a nursing education program may be eligible to take the certification exam and work as a certified medication assistant.

Certification by Examination

Certification exams for Medication Assistants are administered through a computerized competency test. The Board has approved D&S Diversified Technologies-Headmaster, LLP, to provide examinations and scoring services for the Medication Assistant Certification Examination. In Arkansas, exams are administered electronically using TMU[®] Internet connected personal electronic devices, that are securely proctored.

The pass rate performance for the MA-C programs in Arkansas has increased from 68.2 percent in FY23 to 84.9 percent in FY24. This is a 16.7 percentage point increase in FY24.

Certifications Issued by Renewal

A Medication Assistant-Certified (MA-C) is required to renew certifications biennially. The MA-C must complete eight (8) hours of Arkansas State Board of Nursing approved continuing education courses during each renewal period.

There were 136 MA-C renewals issued during FY24, as compared to 48 renewals in FY23. This is an increase of 88 renewals, or 183.3 percent.
