Respondent is to file with the board a university transcript showing successful completion of three hours graduate level coursework in Ethics from an accredited institution of higher education, if course is online it must be

from a program approved by the board and a transcript of the coursework must be approved by the board prior to 1-1-26. Responded shall complete six hours of continuing education on relationships and boundaries, in addition to what is required for licensure renewal. Documentation of the completed hours must be submitted to the board prior to 1-1-26. Respondent must attend counseling sessions with a LPC or LMFT at least twice per month for a period of six months. At conclusion of counseling, a report must be submitted by the LPC or LMFT documenting attendance and progress. Respondent is to attend supervision upon completion of suspension, with a board approved supervisor at a ratio of one supervision hour to every ten direct client contact hours for a total of 20 supervision hours and 200 direct client contact hours. Respondent must submit a supervision agreement to the board that must be approved before any clinical practice can begin. All complaint documents are to be sent to the supervisor. Supervisor must submit documentation of attendance and progress during supervision at the completion of the required meetings.
