

Solid Tumor Rules - STM MANUAL

- It is encouraged to download the manual, do not use the on-line version
 - Individual site modules are no longer provided
- Use General Instructions along with site-specific rules
- An Ambiguous terminology work group will be reviewing ambiguous terms for coding histology only for the Solid Tumor Rules
 - Ambiguous terms used in reportability, and EOD are not being reviewed
- Cancer PathChart search tool has been added

RULES FOR ARKANSAS CANCER CASE REPORTING

In accordance with Arkansas cancer reporting law, all licensed health care facilities and providers are required to report cancer cases to the ACCR no later than six months after the date of diagnosis of cancer and/or initial treatment of cancer.

All cancer cases that were diagnosed or began initial treatment on or before **August 31, 2024**, should have been reported to ACCR. If you still have cases remaining from this period, report them immediately. Cases must be reported via WebPlus.

FOCUS AREAS

Lung

- Adenocarcinoma; carcinoma
 - Used interchangeably
- Bronchus, is not always equivalent to mainstem bronchus
 - Only apply C340 mainstem when specifically stated in OR report of by a physician
 - O When only bronchus, code to lobe where the bronchial tumor is located
- Table 1 of the STM: Coding Primary Site
 - o Provides terminology and laterality specific to site terms and code application, e.g.,
 - Base of lung, Bilateral = Lower lobe C343
 - Suprahilar NOS, Bilateral = Lung NOS C349
 - Lingula of lung, Left = Upper lobe C341
- Coding Histology
 - o Code the most specific histology or subtype/variant regardless of description as
 - Majority or predominant
 - Minority of tumor
 - A component
- Grade Table 2
 - o Grade G4: Undifferentiated, including anaplastic
- AJCC Online Staging
 - o The Explanatory Notes section provides several helpful resources on 'Multiple Tumors'
 - Including Table 36.4 Clinical criteria to categorize a lesion as a separate tumor nodule (intrapulmonary metastasis)

ETC CORNER

Marie & Pierre Curie discovered radiation towards the end of the 19th century, and they were also the first to provide the effective non-surgical cancer treatment- radiation treatment. However, what we call radiation treatment today has come a long way since the early 1900's. As radiation has evolved over the last century, it's important to reflect on how these great minds helped save thousands of lives. As Oncology Data Specialist professionals, we are tasked with breaking down several components of radiation treatment including energy utilized, method of delivery, and targeted areas of delivery to the patient. Advances in radiation treatment and the evolution of cancer data collection can sometimes make coding these treatments difficult. The STORE manual has evolved since 2018 to include extensive case examples and scenarios in the "CTR Guide to Coding Radiation Therapy Treatment in the STORE". The 2025 STORE MANUAL Appendix R provides the newest coding guidelines and case examples based on many different scenarios. There are now more case examples than ever before, ranging from the gold standard of radiation treatment per cancer site to nuanced cases with cancer registrar inquires. In this resource, you will find that many case examples are taken directly from the CAnswer Forum. Unique situations, real cases, and feedback with coding guidance from ACoS are added daily. The CAnswer Forum is free to both certified registrars and students alike; registration is required. These are excellent resources for radiation coding and are available online. I highly recommend reviewing the 2025 STORE Manual and visiting the CAnswer Forum at https://cancerbulletin.facs.org/forums/help and register today!
