

## **Commission Members**

### **Mike Cranford of Foreman (term expires in 2031)**

Mike Cranford was appointed to the Commission by Governor Asa Hutchinson on March 28, 2022. He previously served a term as a Commissioner when appointed to the Commission by Governor Mike Beebe on January 26, 2009. In 1988, while attending a holiday beach party on the Red River, Mike made an ill-fated dive into shallow water, injuring his spinal cord at C6. He attended Southern Arkansas University and UA-Cossatot where he received his A.A.S. in Accounting. He previously served as the county judge for Little River County. Mike is a deacon and Sunday School teacher at First Baptist Church of Foreman. He is involved in numerous civic and service organizations including the County Judges Association of Arkansas and Association of Arkansas Counties.

Mike is an avid outdoorsman who says he "works to be able to hunt." He is the founder and president of Southern Sportsmen Foundation, a 501(c)(3) non-profit corporation that is dedicated to providing quality hunting and outdoor opportunities to men, women, and children with severe mobility impairments and/or life-threatening illnesses. Mike's knowledge and personal experience in state and local government are a great resource to the Commission. He lives with his family in Foreman, AR.

### **Dr. Patricia Knott of Conway (term expires in 2029)**

Dr. Patricia Knott was appointed to the Arkansas Spinal Cord Commission by Governor Asa Hutchinson on October 23, 2019.

Dr. Knott is a graduate of Xavier University in New Orleans, LA; obtained her MD at Louisiana State Medical Center in New Orleans; and completed her residency at LSU Medical Center in Physical Medicine & Rehabilitation.

She has practiced medicine for 29 years and has served as the Medical Director for two freestanding Rehabilitation hospitals.

Presently, Dr. Knott practices part-time in active patient care. She now serves on the the Arkansas Tobacco Control Board and the Spinal Cord Commission. She also works full time as a Medical Director for a major insurance company.

Her appointment to the Commission will expire on January 14, 2029.

### **LeDanté Walker of Hot Springs (term expires in 2026)**

LeDanté Walker was appointed to the Commission by Governor Asa Hutchinson on October 16, 2017. LeDanté sustained a spinal cord injury in a single car accident in 1997. He was ejected from the back seat of the car causing a fractured neck and an SCI at the C4-C5 levels.

In 2010, LeDanté began working at the Spa Area Independent Living Center (also known as SAILS). He is currently working as an Independent Living Advocate / Targeted Case Manager and assists individuals with resources to ensure successful community living. LeDanté is also a certified Medicare counselor, homeowner advocate for Garland County Habitat for Humanity, member of the Difference Makers of Hot Springs, and currently sits on the Transportation Advisory Committee for the city of Hot Springs.

LeDanté currently resides in Hot Springs, AR. His work with independent living services and advocacy for individuals with disabilities brings with him a wealth of knowledge and experience to the Commission. He continuously strives to reach others by setting an example for others based on how he lives.
