FY 2021 Medical Marijuana Data Summary

The Arkansas Medical Marijuana Amendment of 2016 requires the Arkansas Department of Health and the Arkansas Department of Finance and Administration to submit specific Fiscal Year (FY) data related to Medical Marijuana activities.

The FY 2021 data updates are presented below.

Applications submitted for Registry ID Card = 77,042 Patients (Please refer to page 4 for caregivers & visitors information.)

Applications filed for renewal = 25,215 Patients (Please refer to page 5 for caregivers & visitors information.)

Patients' qualifying medical conditions = refer to page 6

Number of Registry ID Cards revoked = 0

Number of physicians providing written certifications = 960

Number of licensed dispensaries = 38; Number of dispensaries in operation = 36

Number of licensed cultivation facilities = 8; Number of cultivation facilities in operation = 5

Number of licenses revoked to operate dispensary = 0

Number of licenses revoked to operate cultivation facility = 0

Number of dispensary agents = 798

Number of cultivation facility agents = 486

- This information represents the total of both new and renewed applications submitted and approved from July 1, 2020 to June 30, 2021
- A total of 77,042 patients submitted applications for a Medical Marijuana Registry ID Card. Of those, 75,704 applications were approved. There were 1,338 applications pending due to incomplete information.
- A total of 1,113 caregivers submitted applications for Medical Marijuana Registry ID Cards. Of those, 584 applications were approved. There were 529 applications pending due to incomplete information.
- A total of 8,962 visitors submitted applications for Medical Marijuana Registry ID Cards. Of those, 8,750 applications were approved. There were 212 applications pending due to incomplete information.
- There were no revocations of patient or caregiver Registry ID Cards during the fiscal period.



- A total of 25,215 patient renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 23,618 patient renewal applications were approved. There were 1,597 applications pending due to incomplete information.
- A total of 185 caregiver renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 110 renewal applications were approved. There were 75 renewal applications pending due to incomplete information.
- A total of 5,172 visitor renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 4,958 visitor renewal applications were approved. There were 214 renewal applications pending due to incomplete information.
- Due to the COVID-19 pandemic, the expiration date for all registry cards was suspended through September 30, 2020, allowing many cardholders to postpone their renewal until FY21.

Patients' Qualifying Medical Conditions

Figure 1: Patients' Qualifying Medical Conditions, Arkansas, FY 2021



- The most prevalent qualifying medical condition among Medical Marijuana Registry ID Card recipients was intractable pain unresponsive to medicines, treatment, or surgery for >6 months (31.9%).
- The second and third most prevalent conditions were post-traumatic stress disorder (30.5%) and severe arthritis (11.7%), followed by peripheral neuropathy (5.7%) and fibromyalgia (5.0%).
- The least prevalent medical conditions reported were amyotrophic lateral sclerosis (< 0.1%), Alzheimer's disease (0.1%), and Tourette's syndrome (0.1%).




Percent of Approved Patients with Medical Marijuana Registry ID Card by Gender, Arkansas, FY 2021




Percent of Approved Patients with Medical Marijuana Registry ID Card by Race/Ethnicity, Arkansas, FY 2021
