FY 2024 Medical Marijuana Data Summary

The Arkansas Medical Marijuana Amendment of 2016 requires the Arkansas Department of Health and the Arkansas Department of Finance and Administration to submit specific Fiscal Year (FY) data related to Medical Marijuana activities.

The FY 2024 data updates are presented below.

Applications submitted for Registry ID Card = 101,364 Patients (Please refer to page 4 for caregivers & visitors information.)

Applications filed for renewal = 70,709 Patients (Please refer to page 5 for caregivers & visitors information.)

Patients' qualifying medical conditions = refer to page 6

Number of Registry ID Cards revoked after being approved = 2

Number of physicians providing written certifications = 1,191

Number of licensed dispensaries = 37 Number of dispensaries in operation = 37

Number of licensed cultivation facilities = 8 Number of cultivation facilities in operation= 8

Number of licensed processor facilities = 8 Number of processor facilities in operation = 7

- This information represents the total of both new and renewed applications submitted and approved from July 1, 2023 to June 30, 2024.
- A total of 101,364 patients submitted applications for a Medical Marijuana
 Registry ID Card. Of those, 101,006 applications were approved. There were
 358 applications pending due to incomplete information.
- A total of 830 caregivers submitted applications for Medical Marijuana
 Registry ID Cards. Of those, 421 applications were approved. There were 409 applications pending due to incomplete information.
- A total of 12,041 visitors submitted applications for Medical Marijuana
 Registry ID Cards. Of those, 11,706 applications were approved. There were
 335 applications pending due to incomplete information.
- There were 2 revocations of patient or caregiver Registry ID Cards during the fiscal period after being approved.



- A total of 70,709 patient renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 64,720 patient renewal applications were approved. There were 5,989 applications pending due to incomplete information.
- A total of 229 caregiver renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 142 renewal applications were approved. There were 87 renewal applications pending due to incomplete information.
- A total of 9,855 visitor renewal applications were submitted for Medical Marijuana Registry ID Cards. Of those, 8,870 visitor renewal applications were approved. There were 985 renewal applications pending due to incomplete information.

- The most prevalent qualifying medical condition among Medical Marijuana
 Registry ID Card recipients was Post-traumatic stress disorder (34.9%).
- The second and third most prevalent conditions were Intractable pain, which
 is pain that has not responded to ordinary medications, treatment or
 surgical measures for more than six (6) months (29.0%) and severe arthritis
 (11.5%), followed by peripheral neuropathy (5.3%) and fibromyalgia (4.2%).
- The least prevalent medical conditions reported were amyotrophic lateral sclerosis (< 0.1%), Alzheimer's disease (0.1%), and Tourette's syndrome (0.1%).





Percent of Approved Patients with Medical Marijuana Registry ID Card by Gender, Arkansas, FY 2024






Percent of Approved Patients with Medical Marijuana Registry ID Card by Race, Arkansas, FY 2024
