There was discussion about the content of the IBHRE - Certified Electrophysiology Specialty (CEPS) exam. Jason Martin spoke about the exam and the governing board for this credential. There are 113 people in Arkansas with RCIS or RCES credentials. There are 37 IBHRE credentialed individuals.

There were some unanswered questions from the committee. Mr. Thompson suggested tabling this discussion until the questions could be answered. Dr. Paylor will request specific information at a later date in order to gain clarification prior to a vote. Dr. Paylor made the motion to table the discussion, and it was seconded by Dr. Nelson.
